## C. AGENDA ITEMS:

4. Report from facility manager: He reported that the evacuation site has officially moved on but left behind some baggage and damage. The floor has been damaged in the main hall and in the lobby. He reported that he is currently working with the Red Cross to get them repaired. He stated that a couple of people with trailers, a family of 7, and an elderly lady were not able to make the transition to the new transition site. He stated that he paid \$80.00 to have them moved and is patiently waiting for the other one to be moved. He further reported that he transported one elderly lady to the new evacuation center in Tulare and the family to a residence in Lindsay. He also reported that Michael and Jordan are both performing well in their roles. He reported, as per our last meeting, he has created and filled out evaluation reports on both.

Samuel reported that the celebration of life for Howard will be held on May 13, 2023 at 3:00 p.m. at the memorial building. Johnny Carr reported that the celebration of life for Sandi Carr will be held on May 7, 2023 at 2:00 p.m.

Since there was no further business, the meeting was adjourned
